A RESOLUTION OF THE COMMUNITY REDEVELOPMENT AGENCY FOR THE CITY OF SAFETY HARBOR, FLORIDA, APPROVING MODIFICATIONS TO THE COMMUNITY REDEVELOPMENT PLAN, ALSO KNOWN AS THE “DOWNTOWN MASTER PLAN”, TO UPDATE THE VISION AND VALUED TREASURES WITHIN THE INTRODUCTION, UPDATE THE TAX INCREMENT FINANCING PROJECTIONS AND REDEVELOPMENT OBJECTIVES AND PINELLAS COUNTY TAX INCREMENT FINANCING ELIGIBILITY POLICIES, UPDATE THE REAL TIME RECORD OF COLLABORATIVE ENGAGEMENTS, AND PROVIDE A CORRECTED LEGAL DESCRIPTION FOR THE COMMUNITY REDEVELOPMENT AREA; RECOMMENDING THE CITY COMMISSION ADOPT SUCH MODIFICATIONS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE
