

RESOLUTION NO. 2021 – 21

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, AMENDING THE BUDGET FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021 BY APPROPRIATING EXPENDITURES AND FUND RESERVES WITHIN THE CAPITAL PROJECTS FUND TO PURCHASE AUDIOVISUAL EQUIPMENT FOR COMMISSION CHAMBERS; PROVIDING FOR PUBLICATION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City Commission at any time within a fiscal year or within 60 days following the end of the fiscal year, may amend the budget for that year by resolution; and

WHEREAS, having observed all appropriate procedures required by Florida Statutes, the City Commission deems it necessary, proper, and in the best interest of the public to amend said budget.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED, that:


Section 1. The budget for the 2020-2021 fiscal year is hereby amended as incorporated herein and the amount stated as proposed revenue and expenditure shall be available for appropriation for the line items and purpose named below:
