**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF
SAFETY HARBOR, FLORIDA, AMENDING THE BUDGET FOR THE
FISCAL YEAR COMMENCING OCTOBER 1, 2023 AND ENDING
SEPTEMBER 30, 2024 BY APPROPRIATING GENERAL FUND
CONTINGENCY FUND RESERVES FOR MATTIE WILLIAMS
NEIGHBORHOOD FAMILY CENTER BUILDING EXPANSION;
PROVIDING FOR PUBLICATION; AND PROVIDING FOR AN
EFFECTIVE DATE**

WHEREAS, the City Commission at any time within a fiscal year or within 60 days following the end of the fiscal year, may amend the budget for that year by resolution; and

WHEREAS, having observed all appropriate procedures required by Florida Statutes, the City Commission deems it necessary, proper, and in the best interest of the public to amend said budget.

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF SAFETY HARBOR, FLORIDA, IN SESSION DULY AND REGULARLY ASSEMBLED, that:

Section 1. The budget for the 2023-2024 fiscal year is hereby amended as shown in Exhibit "A", attached hereto and incorporated herein.



Section 3. This Resolution shall become effective immediately upon its passage and adoption.







SUMMARY

A need exists to amend the Fiscal Year 2024 budget.

The City Manager is seeking to transfer \$200,000 from the Contingency/Unanticipated Expenditure Fund Reserve to grant funding for the Mattie Williams Neighborhood Family Center expansion project. The Contingency/Unanticipated Expenditure Fund Reserve has a current balance of \$300,000.
