# NEIGHBORHOOD PROJECT GRANT APPLICATION

#### Process Summary

*Eligible projects include physical improvements such as entryway signs, fencing, walkways, fountains and lighting in a common area or neighborhood entryway. Reimbursement is available for the full cost of the project up to a maximum of \$5,000. Lighting should be designed and installed with energy saving fixtures. Maintenance costs are not eligible. After the application deadline, staff will send a letter of notification regarding the grant. After being notified of a grant award, work may begin. Once the work is complete, the applicant provides copies of cancelled checks and after photos to the City and a check will be processed to reimburse the applicant. All work must meet applicable codes. Work must be completed within 6 months or the City of Safety Harbor may cancel the grant.*

***A total maximum of one grant may be approved for each association (neighborhood project or beautification matching) per cycle.***
